Discussion

From the first years of independence in Uzbekistan special attention was paid to the formation of a multiparty system. In particular, after Uzbekistan gained independence in 1991, the Constitution of the Republic of Uzbekistan adopted in 1992 laid out the legal framework for the activities of political parties. According to Article 58 of this document, political parties function as a means of expression, formation and implementation of the political will of citizens¹.

In order to determine the role and significance of political parties in the life of society, it is important to analyze their participation in the legislative process. Elections to the Legislative Chamber of Oliy Majlis of the Republic of Uzbekistan have been held on the basis of a multi-party system since 1999. As of 2023, there are five major political

parties operating in the country: the Liberal Democratic Party of Uzbekistan (UzLiDeP), the People's Democratic Party of Uzbekistan, the Democratic Party of National Restoration of Uzbekistan, the Social Democratic Party of Justice and the Ecological Party. These parties contribute to ensuring the stability of the country's political system by representing the interests of different social strata.

The role of political parties in the electoral processes is also noteworthy. As a result of the parliamentary elections held on December 22, 2019, UzLiDeP won 43 seats, the National Recovery Party 35, the Social Democratic Party of Justice 24, the People's Democratic Party 22 and the Ecological Party 15. These results indicate that the country has a multi-party system, but there are disputations on the level of real political rivalry between the parties. International experts and local analysts say that the exact ideological differences between the parties have not yet been fully formed, and that most of the parties' programs are aimed at solving common socio-economic problems.

In order to consider the social significance of political parties in society, it is necessary to analyze their methods of working with the public and their influence on social activism. According to the results of the polls conducted in 2022, 35% of respondents expressed satisfaction with the activities of political parties, while 42% stated that parties do not adequately address the problems of society. There is a low level of trust in political parties, especially among young people. A 2021 report by the Union of Youth of Uzbekistan noted that only 18% of citizens between the ages of 18 and 30 expressed their desire to join a political party. This underscores the need to improve the strategies of parties to work with the younger generation.

The influence of political parties on society is measured not only through electoral processes but also through the bills and initiatives put forward by them. In recent years, the parties have expressed initiatives promoting social reforms in various spheres. For example, in 2022, the Social Democratic Party of Justice put forward a bill to improve the education system, while the National Recovery Party developed a number of projects to preserve and develop the national culture. Still, experts say, party initiatives still have enough influence at the level of public policy².

Looking at the international experience, in developed democratic countries, political parties function as independent institutions representing the interests of different

segments of society. For example, parties in Germany, the UK and the USA are funded through foundations, and they collaborate with independent research centers, public institutes. In Uzbekistan, however, the issue of the financial independence of the parties remains relevant. According to the law "On Political Parties" adopted in 2020, parties are funded from the state budget, but the mechanisms for attracting funds from the private sector and citizens have not yet been fully developed.

Thus, although the system of political parties in Uzbekistan continues to develop, there are still problems to be solved. Parties should work on the exact formation of their ideological orientation, increase the participation of citizens in the electoral process, strengthen the mechanisms for working with young people and create an atmosphere of political competition based on international experience. At the same time, it is necessary to strengthen the appropriate legal framework to transform political parties into financially independent institutions and to take their initiatives seriously at the level of public policy.

The political system of the Republic of Uzbekistan is entering its new stage and the role of political parties in this process is expected to increase further. One of the most important tasks is to create modern and effective conditions for the functioning of these institutions so that they serve to more effectively protect the interests of society, increase civic activity and strengthen democratic values in the country.

Conclusion

Political parties in the Republic of Uzbekistan are integral to the life of society and play an important role in the development of democratic processes in the country. They carry out tasks such as increasing the political activity of citizens, forming public policy and representing public interests. During the years of independence in Uzbekistan the system of political parties gradually developed and today there are five major political parties. These parties are expanding their sphere of influence by participating in the lawmaking process, protecting the needs of citizens and representing the interests of different segments of society. The results of the analysis of the role of political parties in the political process show that they are directly involved in the strengthening of democratic principles in the country. In particular, through the parliamentary elections, parties had the opportunity to gain seats in Oliy Majlis and advance their representatives in the public administration system. The results of the 2019 parliamentary elections confirm that the multi-party system is

Based on international experience, it can be noted that in developed democratic countries, political parties function as an independent institution, playing an important role of mediation between the state and society. Uzbekistan is also carrying out reforms in this direction, however, the urgent task remains to further strengthen the institutional base of party activities, ensure their financial independence and form a real political competitive environment. Thus, although the system of political parties in the Republic of Uzbekistan is developing on the basis of democratic principles, it is necessary to continue a number of reforms in order to orient them to work more effectively, increase their political and social influence and strengthen the trust of citizens. In this process, such areas as improving the electoral system, encouraging political parties to actively cooperate with different segments of society, as well as taking their initiatives more seriously at the level of state policy will play an important role.

Further democratic development of Uzbekistan depends on the effectiveness of the functioning of political parties, and increasing their political and social significance should be regarded as a strategic direction in the interests of the state and society.
