THE ROLE OF POLITICAL PARTIES IN FORMING A RULE OF LAW AND CIVIL SOCIETY IN ENSURING THE DEVELOPMENT OF UZBEKISTAN

Abstract

This article analyzes the role of political parties in the process of forming a rule of law and civil society in the Republic of Uzbekistan. Political parties, as political institutions of society, play an important role in state administration, contribute to the development of democratic principles and serve as an important factor in the formation of civil society. After Uzbekistan gained independence, the principle of multi-party system was introduced in the political system, and political parties have been actively participating in the process of determining state policy and implementing it. The article discusses the impact of political parties on the development of the country, their participation in the legislative and executive branches, their role in increasing the political activity of citizens, and their contribution to strengthening the principles of the rule of law.

These parties are pushing socioeconomic reforms in parliament and in local authorities based on their programs.

The role of political parties in strengthening the rule of law and the development of civil society largely depends on their position in electoral processes, legislative initiatives and measures aimed at increasing political activity of the population. This article analyzes the role of parties in the political system of Uzbekistan, their participation in public administration and their interaction with civil society institutions.

Results

1996. This law clearly defined the role of parties in society and public administration and defined their rights and duties.

In particular, the "Electoral Code" adopted in 2019 is aimed at ensuring the transparency of the electoral process, which clearly defines the participation and powers of political parties in elections. - 2. Legislative initiatives and their role in public administration Political parties, as an important institution representing the interests of different segments of society, are actively involved in the legislative process. In the Legislative Chamber of Oliy Majlis there are factions of parties that put forward bills in economic, social and political spheres. For example, in 2022, the Social Democratic Party of Justice put forward a bill to reform the education system, while the National Recovery Party took initiatives to preserve national culture and historical heritage.
- **3.** Role in the formation of civil society and increase of political activity Political parties work to increase the political activity of citizens, increase their legal culture and promote democratic values. In particular, various social projects and propaganda events organized by parties make it possible to involve young people and other social groups in the political process.
- **4. Institutional development and problems of political parties Despite** the growing role of parties in the political system of Uzbekistan, their influence in society is still relatively limited. Many experts believe that party initiatives fail to have enough influence on practical political decisions. Also, political parties face some challenges in terms of financial independence and strengthening organizational capacity.

In general, political parties in Uzbekistan play an important role in the formation of the rule of law and civil society. Their participation in the electoral processes, legislative initiatives, cooperation with civil society and democratic reforms contribute to the sustainable development of the country. At the same time, the tasks facing the parties include increasing their social influence, strengthening the

For instance, in 2022, the Social Democratic Party of Justice put forward a bill to improve the education system, while the National Recovery Party came up with a number of initiatives to preserve and develop the national culture. Meanwhile, in 2021, the Environmental Party put forward a series of bills to protect the environment and transition to a green economy. Political parties also play an important role in electoral processes. Five parties took part in the 2019 parliamentary elections, in which UzLiDeP won the majority of votes and won the main position in

International experts say the parties' initiatives and programs still do not have enough impact on public policy. In addition, the need to strengthen the financial independence, organizational potential and direct contacts of the parties with citizens remains urgent. In this regard, it is necessary to continue reforms to further democratize the political system of Uzbekistan, strengthen political parties and increase their role in public life. Parties should be active not only before elections, but throughout the entire political process, cooperate closely with the public, develop strategies based on real actions to protect the interests of their electorate.

In conclusion, political parties in Uzbekistan play an important role in the formation of a democratic legal state and civil society. Their participation in the electoral processes, legislative initiatives, public relations and activities in the development of civil institutions contribute to the steady development of the country. However, it is necessary to deepen reforms in order to eliminate existing problems and further increase the influence of the parties. In the process, political parties should pay greater attention to work directly with their electorate, seek to find solutions to real problems of the people, and become an active participant in the political process.

Conclusion

The role of political parties in the process of ensuring the development of Uzbekistan, formation of a legal state and civil society is invaluable. As a result of the reforms carried out since the country gained independence, political parties have taken a
